

Terms of Reference

Toronto Pearson 2013 Air Quality Study Community Advisory Committee

Purpose

- The GTAA is updating its Air Quality Study and Human Health Risk Assessment (HHRA). The previous study, undertaken in 2000, forecast out to 2015.
- With passenger traffic increasing from the previous baseline and the airport function more effectively, it is the right time to update the previous work to ensure that the conclusion both for local and regional air quality are still valid.
- In support of the study, the GTAA will be forming a Community Advisory Committee as a mechanism to seek input from industry and community stakeholders.
- The purpose of these Terms of Reference is to ensure that Advisory Committee participants are aware of expectations, commitments, and the advisory role of the Committee.

Objective of the Committee:

- Provide advice and expertise to the GTAA Air Quality Study and HHRA to ensure that industry best practices are being met.
- Provide an opportunity for the general community to receive information, ask question and engage in dialogue concerning scientific and technical concepts necessary for informed discussion.

Role & Responsibilities of Committee Members:

- Participate in ways that reflect a commitment to building a constructive working relationship between members.
- Be prepared to invest time and energy towards learning about the technical and regulatory aspects of air quality study.
- The Committee will not be asked to formally approve or disapprove any actions.
- This is a volunteer committee, and participants will not receive remuneration.

Roles & Responsibilities of the GTAA:

- Coordinate and facilitate the meetings
- Produce a record of each meeting

Criteria of Community Members from the general community:

- Community members will meet the following criteria:
 - Are interested in the air quality surrounding Toronto Pearson
 - Live within a 8 km radius of airport property (see below for qualifying postal codes)
 - Are able to attend regular meetings beginning Monday, December 9; we anticipate up to 4 meetings over the course of the project
 - Are willing to volunteer their time
 - Are connected to their community and have networks to disseminate information and bring in feedback from their constituents.
- Interested community members will be asked to apply by submitting 500 words or less explaining why they are interested in serving on the committee and the positive contributions they can make, with particular emphasis on the networks they bring, and how they will be able to share information with their neighbours.
